FHLBI announces early closing of MPP trading hours, advances window in observance of Martin Luther King Day

Due to the early closing of the bond market in observance of Martin Luther King, Jr. Day, MPP trading hours will close at **1:00 pm** Indianapolis time on Friday, January 16, 2009. Scheduled fundings will still be completed on Friday, and MPP staff will be available during normal business hours.

The FHLBI advances window will close at **12:00 p.m.** Indianapolis time. No trades will be executed after that time except for our variable rate advance product. We will honor requests for our variable rate advance until **2:00 p.m.** Indianapolis time.

As a reminder, the FHLBI will be closed on Monday, January 19, 2009, in observance of Martin Luther King, Jr. Day.
