The Federal Home Loan Bank of Indianapolis invites you to participate in an important effort to recognize, promote, and assess the community investment activities of financial institutions in your local communities. In order for financial institutions to retain access to Federal Home Loan Bank (FHLBank) long-term advances, they must meet certain standards of community investment required by the Financial Institutions Reform, Recovery and Enforcement Act (FIRREA) of 1989.

Each quarter the Federal Housing Finance Agency selects a number of FHLBank members for a Community Support Review. In determining the impact of an institution's community support program, comments from community groups and interested members of the public are considered. Attached is a list of institutions selected for this quarter. If you or your organization has any comments, negative or positive, on the performance of any of these lending institutions in meeting the credit needs of their communities, **please send them to the Federal Housing Finance Agency on or before December 31st, 2015**, as indicated below.

Even if you do not have specific comments regarding institutions under review this quarter, your thoughts or perspectives on unmet or underserved community investment needs would be appreciated and will greatly assist the FHLBI in directing our technical assistance and community investment programs to our members.
