- Message Board shows you messages from FHLBank Indianapolis.
- Apply Now Buttons will open a new application for the selected program.
- Application Status / Continue Application shows you the progress of applications you have already started.
- Reports shows you data reports of applications you have submitted.

- The "**My Tasks**" section is found at the top left of the homepage. This is where you can see items requiring action.
- The "Assigned to Me" inbox holds any applications or adjustments that have been sent specifically to you from FHLBI, or from another staff person within your organization.
- The "Assigned to my Group" inbox holds any applications or adjustments that have been sent to your user type from FHLBI, or from another staff person at your organization.
- The "My Work in Progress" inbox holds any applications or adjustments that you open, but do not submit. This applies to new applications and adjustments that you create, or others that you pick up from your "Assigned to Me" or "Assigned to my Group" inboxes.
- The "Messages from The Bank" inbox holds any messages sent to you from FHLBI.
- The "Post Funding" inbox holds any applications that have been approved and disbursed by FHLBI and are now ready for you to close/ complete and submit the required closing or project completion data and documents.

If Disaster Recovery Program (DRP) has been activated, you will see the same information regarding funds for the DRP program reflected in this section.

My Totals

"**My Totals**" displays the amount of funds available to your organization, the total amount of funds disbursed to your organization, the amount of funds requested by your organization that are pending FHLBI's review, and the remaining funds available to your organization for the current round. The "Continue Application" button will display any applications that have not yet been submitted to FHLBI.

Reports

There are two reports available to you in the system.

The "Funding Report" provides data on all your fully completed applications. You can run this report to gather data on your organization's historical disbursements dating back to 2005.

The "**Application Report**" provides data on all your applications, regardless of whether they have been completed. You can view data on all your organization's historical application or adjustment records going back to 2005 with this report.

Application Roles

Each member must have a submitter and authorized signer role in the system. These roles are designated by your institution at the time of user registration.

- Submitter The submitter can create applications and adjustments, and enter all the information associated with these processes.
- Authorized Signer Has the same abilities as the Submitter, but they must sign off any any new application created by the Submitter.

Product Selection

To start an application, click the "Apply Now" button for your desired program type – Purchase or Rehab.

You will be provided with a list of products available under the selected program type, and the amounts of funds available to you under those products. Click continue to begin assembling your application.

Throughout the application, each step will allow you to enter comments. To do so, enter your comments in the Comments box near the bottom of the screen, and click the "Save Notes" button.



Adding Household Members

On Step 1 – Household Information, click the "Add" button near the bottom of your screen.

This will bring up a pop-up window to add details about a household member. Fill in this information and repeat for each household member. For each household member you add in the pop-up window, you will see their information reflected on the Step 1 main page. If you need to edit or remove a household member's information, you can select the radio button next to their name on the main page and select the "View or Modify" or "Delete" button.

Note: If there is no income for any of the household members, you must select "Yes" to the "Does household member have income?" question for at least one household member found on the pop-up window. See notes under Adding Income Information.

Once you have added all household members, select "Next" at the bottom right corner of your screen or click directly on the Step 2 box at the bottom center. The seven application steps that must be completed are shown below.



Adding Income Information

Adding income is similar to adding and editing household member information. All household members who were indicated to have income in Step 1 will be listed on the income page. To add an individual's income, click the radio button next to their name and select "Add or Modify".

This will open a pop-up window to enter the household member's income. You will find different tabs for the different income types. If your household member has more than one job, after entering and saving the first job, you can click the drop-down arrow on the field at the top left of the window and select "Add New Employer" to enter the additional job(s). All saved jobs will show up in this drop-down list.

Note (for households with NO income): Click on the "Other Income" tab. Select the check box next to "Income Description" near the bottom of the pop-up window. Save and close the pop-up window.

Once you have entered and saved all income sources for all household members, select "Next" at the bottom right corner of your screen, or click directly on the Step 3 box located at the bottom center.

Adding Property Information

On Step 3 – Property Information, you must fill in all the required information before moving on to the next step. The only information on this page that is not required to be filled in is the Appraised Value. A link is provided to look up census tract

information. Once you have entered and saved all your information, select "Next" at the bottom right corner of your screen or click directly on the Step 4 box at the bottom center.

Adding Financing and Mortgages Information (Purchase Only)

On Step 4 – Financing and Mortgages, you must fill in all the required information before moving on to the next step. Once you have entered and saved all of your information, select "Next" at the bottom right corner of your screen or click directly on the Step 5 box at the bottom center. The Total Costs and Total Sources must be equal before advancing from this step.

Product Eligibility

Step 4 in Rehab, or Step 5 in Purchase, Product Eligibility is where you select which product you wish to use within the application type (Purchase or Rehab) you selected at the very beginning. If the information you entered qualifies the household for one of the products, the products will show at the top under "Eligible Products". If the household does not qualify for one or more products, it will show underneath the "Non-Eligible Products" section, with the non-qualifying responses underneath, as seen below.

If the household does not qualify for any of the available products and the information was entered accurately, the household should be informed that they do not qualify. To delete the application, go back to Step 1 and click the "Delete Application" button at the bottom.

If the household qualifies for the desired product, click the radio button next to the product name, click save, and select "Next" at the bottom right corner of your screen or click directly on the Step 5 box at the bottom center.

Scope of Work (Rehab Only)

On Step 5 – Scope of Work, you will enter the information regarding the deferred maintenance repairs or accessibility modifications.

First you will enter the "Type of Cost." If using AMP you can select Accessibility Modifications or Deferred Maintenance. If using NIP, your only option is Deferred Maintenance.

Once you have selected the Type of Cost, you can select from the options in the "Cost Item" drop down list. Descriptions, which are helpful to explain bathroom modifications, numbers of windows, etc., are optional.

Finally, you will enter the Amount, which should reflect the amount of funds from the grant that will cover this item. Once you have entered all the information for a given repair item, click save. The repair item will now be reflected in the box below. Click New to add additional items.

If you need to edit an already entered item you may select it in the box listing the different repair items, edit the information at the top, and save your changes.

Intake Documents

Step 6 – Intake Documents: This step allows you to upload any documentation related to the application. Required documents have a blue background, while optional documents have a white background.

To add documents, click the "Attach" button. This will bring up a window where you will click "Choose File" from which you can browse your computer to find the appropriate files. Once you select the appropriate file, click the Attach button to the right of the Choose File button, then click Close.

Repeat these steps for any necessary documents. Once you have attached all necessary documents, select "Next" at the bottom right corner of your screen or click directly on the Step 7 box at the bottom center.

Review and Submit Application

Step 7 – Review and Submit Application displays general application information, and several pieces of qualifying information for the selected product. Near the center of the screen there is a checkbox for agreeing to the terms and conditions (see below).

By clicking this you are agreeing to the terms and conditions of FHLBank Indianapolis.

Clicking this link will bring up a window displaying all the terms and conditions associated with the application. You must check off each of the terms and conditions and click save in this window before submitting the application. If you are a Submitter, once you have agreed to the terms and conditions, you may click the "Send Application to Authorized Signer" button. If you are an Authorized Signer, once you have agreed to the terms and conditions, you may click the "Send application to FHLBI" button. Once this step has been completed, you will get a message indicating the application was successfully sent.

Authorized Signer Approval

If the person who created the application was a submitter, the application must be signed off by an Authorized Signer before FHLBI can receive it. Once the application is sent to the Authorized Signer, they will receive an email indicating the application is ready for their sign off. When the Authorized Signer logs in, they will be able to find the application in their 'My Tasks' section of the home page, either in the "Assigned to Me" or "Assigned to My Group" inboxes, depending on if the submitter sent it directly to the Authorized Signer, or to all Authorized Signers.

If the Authorized Signer finds something is missing, they can send it back to the submitter. If they approve of the application, they can sign off in the same manner as listed in the Review and Submit Application description above and send it on to FHLBI for review. If the Authorized Signer has input the application information themselves (no submitter involved), they can submit directly to FHLBI upon agreeing to terms and conditions in Step 7.

SECTION 3: SUBMITTING POST-CLOSING INFORMATION AND DOCUMENTS

This section covers the steps needed to submit post-closing information and documents.

Post Closing Information

Once your application has been approved and disbursed, it will automatically move into your "Post Funding" inbox under the My Tasks section of the home page. To begin submitting your Post-Closing information and documents, open the desired file found in the "Post Funding" inbox. It will open your existing application in Step 8 – Post Closing Information, where you can begin entering the final loan or rehab information depending on the program. Once you have filled out all the information on Step 8, click save, and advance to Step 9 – Post Funding Documents.

Once on Step 9, you will attach the required post-closing documents for the given program. FHLBI.GIVES will indicate what documents are required. Once you have attached all the documents you will agree to the terms and conditions. After agreeing to the terms and conditions, click the Save button, and then click the Send Documents to FHLB button found near the bottom of your screen (see below image). This will send your post-closing information and documents to FHLBI.



If FHLBI has any questions or needs additional documents, the request will be sent back to you. You will receive an email indicating so, and once again, it will show in your Post Funding inbox. You can pick the application up from there, address FHLBI's concerns, and submit your post-closing information and documents back to FHLBI.



SECTION 4: REQUESTING AN ADJUSTMENT OR RETURNING FUNDS

This section covers the steps needed to request an adjustment or return funds to FHLBI.

In the FHLBI.GIVES system, the adjustments section is where you submit an adjustment request to return funds or indicate a change in property status that does not result in a return of funds. To create a new adjustment in the FHLBI.GIVES set-asides system, click on the "File" drop down menu at the top left of the home screen, and click the "New Adjustment" button. This will open the Adjustments workflow screen and allow you to begin creating your adjustment.

First you will need to select the application that you would like to adjust. To select an application, you can click the small question mark next to the "Application Number" entry field, pointed out below.

This will bring up a pop-up that allows you to search for your application. You can search by application number or household name, which can be selected in the "Search By" drop down box. Enter the name or application number you want to search for in the "Text to Match" field. You may enter the application creation date range you are looking for or leave it blank to search all records.

The results of your search will show at the bottom of the page once you click the search button. Select your application, then select your adjustment type. The adjustment types and descriptions are listed below:

Adjustment Type	Description
Return of Unused Funds	Whether partial or the complete amount, any time funds are not used they must be returned
Payoff	When a property is sold or refinanced within the retention period and funds are required to be returned (HOP Only)
Recapture	When there has been a compliance issue discovered and funds must be returned as a result
Property Disposition	When a property has been sold or refinanced and the resulting calculation in the "Payoff" section is equal to zero, or other changes to the property title, such as a death, requiring no return. (HOP Only)



After selecting the appropriate adjustment type, complete the remaining information required near the bottom of the page. Once you have completed the information in Step 1 - Adjustment, click the next arrow on the bottom right, or Step 2 – Documents at the bottom center. Attach the appropriate documents based on your adjustment type and click the next arrow on the bottom right, or Step 3 – Review and Submit Adjustment at the bottom center.



they will send the adjustment back to you. If your adjustment is sent back, you will receive an email and the adjustment will show in your "Assigned to My Group" inbox.

In certain situations, FHLBI will create adjustments and send them to you. You will receive an email notification if this occurs. When you sign in it will show in your "Assigned to My Group" inbox under the adjustment's category near the bottom of the inbox screen. Open the adjustment and verify/ complete the adjustment information, attach any required documents, and submit to FHLBI as described above.
